

# Privacy Statement

Euro-Placements is committed to protecting your privacy and ensuring the use of technology that gives you the most powerful and safe online experience. This Statement of Privacy applies to the Euro-Placements web site and governs data collection and usage. By using the Euro-Placements website, you consent to the data practices described in this statement.

## **Collection of your Personal Information**

Euro-Placements collects personally identifiable information, such as your e-mail address, name, home or work address or telephone number. Euro-Placements may also collect anonymous demographic information, which is not unique to you, such as your ZIP code, age, and gender.

There is also information about your computer hardware and software that is automatically collected by Euro-Placements. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used by Euro-Placements for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Euro-Placements website.

## **Use of your Personal Information**

Euro-Placements also uses your personally identifiable information to inform you of other products or services available from Euro-Placements and its affiliates. Euro-Placements may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

Euro-Placements does not sell, rent or lease its customer lists to third parties.

Euro-Placements may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party. In addition, Euro-Placements may share data with trusted partners to help us perform statistical analysis. All such third parties are prohibited from using your personal information except to provide these services to Euro-Placements, and they are required to maintain the confidentiality of your information.

Euro-Placements does not use or disclose sensitive personal information, without your explicit consent.

Euro-Placements keeps track of the websites and pages our customers visit within Euro-Placements, in order to determine what Euro-Placements services are the most popular. This data is used to deliver customised content and advertising within Euro-Placements to customers whose behaviour indicates that they are interested in a particular subject area.

Euro-Placements websites will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Euro-Placements or the site; (b) protect and defend the rights or property of Euro-Placements, and, (c) act under exigent circumstances to protect the personal safety of users of Euro-Placements, or the public.

Euro-Placements secures your personal information from unauthorised access, use or disclosure. Euro-Placements secures the personally identifiable information you provide on computer servers in a controlled, secure environment, protected from unauthorised access, use or disclosure.
